Competition Rules

Bernards Township resident amateur photographers only. One entry per person. The entered photo:

- must be the original work of the entrant.
- must have been taken within the boundaries of Bernards Township.
- must have been taken in 2017 or 2018.
- must be appropriate for all ages to view.
- must not have been entered previously.
- may be enhanced for esthetics, but should not be “doctored” by adding other graphics or text.

The entry cannot defame or invade publicity rights or privacy of any person, living or deceased, or otherwise infringe upon any person’s personal or property rights or any other third-party rights. Bernards Township reserves the right, in its sole discretion, to disqualify any entry it deems to be offensive, inappropriate, that is not keeping with the terms of these official rules. Entrant must have obtained express written consent to submit any entry that contains persons other than entrant or third-party elements not owned by the entrant and, if requested to do so, produce such written consent from appropriate parties in a form and manner acceptable to Bernards Township. If for any reason, Bernards Township does not feature any of the entries on their website, no compensation or substitution will be provided. By submitting an entry, each entrant grants Bernards Township exclusive right to use, modify, crop distribute the entry and all elements of such entry, including, without limitation, entrant’s photograph and entrant’s name. Bernards Township is not responsible for lost, garbled, damaged, incomplete, delayed or misdirected entries. If for any reason the contest is not capable of running as planned, Bernards Township reserves the right, at its sole discretion to cancel, terminate, modify or suspend the contest.
